



**AGREEMENT** between \_\_\_\_\_ (name) and LPS

It is herein agreed that the Luton Paranormal Society (LPS) will investigate the above mentioned site on the specified date. The investigation will take place according to the terms and conditions specified below. - LPS will arrive at the specified time and will spend approximately one hour setting up equipment before the investigation proper starts.
- The investigation will consist of a number of silent vigils (some in darkness) or experiments which will be discussed with the above named person before they are undertaken. Any experiments (e.g. séance) or conditions (e.g. darkness) that he/she does not feel happy with will not be done or the conditions will be changed. Anything not to be done should be listed below.


- During the silent vigils all people attending the investigation are requested to make no noise and to remain at a fixed location. Low level communication is allowed but should be confined to talk relevant to the investigation. Smoking is not permitted on the site as this will seriously interfere with the investigation and invalidate a lot of the results.
- The investigation will end 30 minutes before the time specified above to allow time to pack up equipment etc. A normal investigation will last for at least 4 hours. This is decided upon at the initial meeting to allow LPS to better plan the event (short investigations mean less set-up time and less experiments etc.).
- The above named person will be asked to pay a refundable deposit of £30 before the investigation can take place. This deposit will be refunded at the end of the investigation. If the above named person changes their mind about the investigation and wishes to cancel then this should be done with 7 days whereupon the deposit will be refunded. If the investigation is cancelled after 7 days from this agreement then the deposit will not be refunded as it will go to pay for the site research which has been done and the incurred costs. In the event of a late cancellation the deposit will still be refundable if another date (within 4 weeks of the original date) is arranged for the investigation. The deposit will be waived for registered charities or at the discretion of LPS. If the fee is waived the detailed reasons as to why must be entered below by LPS.
