03:47 Rap/bang noise heard to Andy and Steph's right on the cellars back wall.

2nd noise heard but sounded more metallic. Andy and Steph investigate possible causes. Air valves considered. This sound is also captured on the camcorder footage and sounds like two wooden doors being bang shut like cellar doors maybe where the barrels of beer would be loaded into the cellar.
