### **Meditation**

Steph gets the impression of being inside a cave, coming out and looking over the Stanton Low site from the North West.

### **Vigil 1: The Path – 21:02 to 21:32**

After arriving just after 21:00 Richard joined Team 1 by the road. Between Arrival and the end of the 30 minute vigil he encountered nothing except the chairs being knocked over by the wind!

21:09 Temperature 8°C facing the church.

9°C facing the path towards the canal.

21:20 Steph gets the impression of horses walking down the path towards the church. Not know if they have a rider or are being walked but they appear to have a saddle.

21:23 Steph takes her camera out of her pocket and the display screen is showing the last picture taken but the camera is switched off.

### **Vigil 2: The Tree by the Bank – 22:05 to 22:35**

Joined by Adrian and Lisa

22:06 Temperature 10°C.

22:10 Steph sees a fire in the field to the East. This looks like the intentional burning of flora but has become out of hand. Has the word 'Fire' repeated again and again in her mind.

22:12 Steph picks up the name 'Ann'.

22:16 Steph sees a small streak of white light move across the field to the East about 100 meters away. Seemed to be no more than 2ft long going North to South.

22:17 During the vigil at the tree Richard sensed a young boy, approximately between 5 - 7 years old, playing around in the field behind the church. He didn't get any visual description of the boy there. Approximately 8 minutes later he got the impression of a hammer & chisel, but it what capacity he had no idea.

### **Vigil 3: Inside the Church – 23:05 to 23:35**

23:06 Entrance to church 4°C. Inside the first room of the church 9°C. The second room of the church 8°C.

23:20 In the church, after approximately 10 minutes (maximum) Richard saw a slim, dark (woman) in the corner of the larger area of the church and moved slowly from right to left, then disappear. The figure was wearing a dark hat of some sort; brimmed but not excessively so.

Steph is sitting in the first room of the church against the far wall. As she stands up and looks around she looks through the doorway to the second room and sees a dark figure standing just

right of the far left corner. As she moves across the width of the room the figure seems to fade away. Her experience happens within a minute of Richards.

23:25 Steph and Richard go to the area where Steph saw the figure. Steph feels a sharp shooting pain in her chest (going from left to right) and feels her upper chest and back feels tight and restricted.

23:26 Just after Steph and Richard had their experiences Andy decided to film them both talking in the rear of the church. He then decided to film where Steph had been sitting, as this was an area he felt drawn to.

He went through the doorway and positioned the camera and tripod facing where Steph had been sitting. The hairs on his back and neck and right arm went up and he felt an intense cold and if someone was standing there next to him, watching him. This was a creepy feeling that only lasted a few moments.

### **Conclusion from Andy**

This could have been a combination of my own subconscious and the cold wind and is on reflection not paranormal proof. But at the time it felt real to me but I need to explore all options before I can say it was paranormal.
