21:58 Sam could smell burning and asks Elaine if she could smell it but she couldn't, it lasted for 20 to 30 seconds.

Sam asks Elaine if she could smell smoke which Elaine couldn't.

22:04 Elaine gets the impression of a man on the look out for trespassers.

### Vigil 2: Avenue of Trees – 22:20 to 22:55

22:20 Sam went to take a picture and her battery had died, Sam had charged the phone fully before coming out.

22:01 Sam hears a whistle coming from her right.

22:22 Elaine can hear a car alarm in the distance.

22:29 Sam has a sense of dread, a feeling of unease, a sense of being watched and a heightened sense of waiting for something to happen.

22:30 Elaine gets the impression of a lady carrying a wicker basket laden with vegetables.

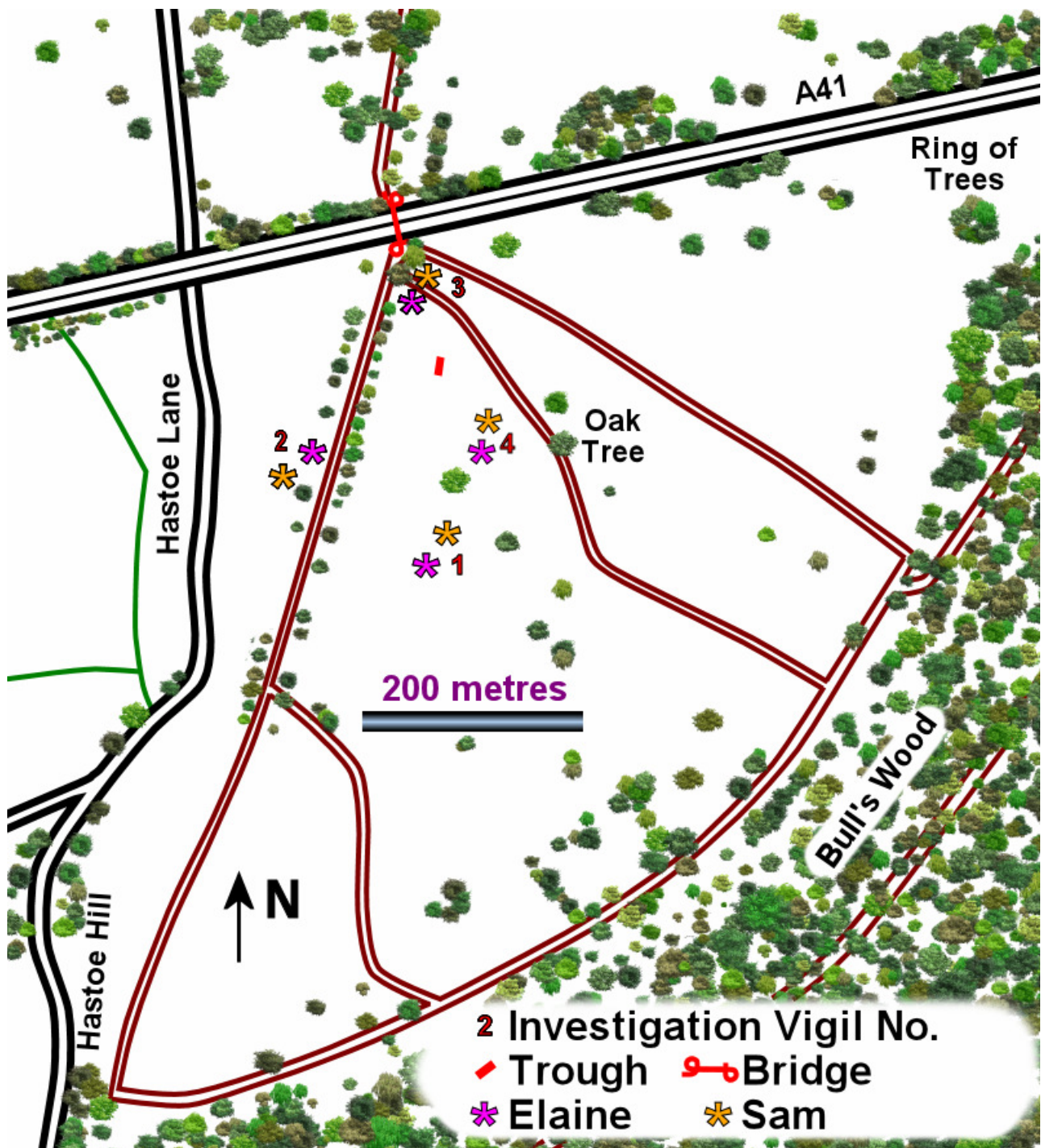

23:20 Elaine can hear the sound of horses galloping.

23:25 Elaine hears heavy breathing to her right; Elaine asks Sam if this was her and she said it was not.

Sam hears heavy breathing to her left; Elaine heard the same thing it was as though it was between both of them.

23:39 As Elaine went to look at Sam a man dressed in black walked past. Elaine or Sam had not heard him. Elaine then radio's over to Andy to let him know that a man was coming over the bridge.

### **Vigil 4: The Dip – 23:55 to 00:30**

For the initial positions of the team members see the plan on the last page.

00:05 Elaine and Sam went near to the first vigil. As Elaine was looking forward she heard a noise behind her, then a couple of seconds later she heard a loud bang as if someone had fallen from a height. Elaine and Sam both shot out of their chairs to see if anything was behind them, Sam saw a figure walk past, Elaine did not see the figure. Sam and Elaine both went to Bill and Richard to let them know what had happened. Bill and Richard went to investigate, while Sam and Elaine stayed under the bridge for the remainder of the vigil.
