Pre-Vigils

Before the vigils started we set up various sound recorders and video cameras to monitor the room. Andy set up his video camera facing from the window towards the kitchen. Steph set her camera up by the door facing the corner of the room where the computer was (where the figure had been seen by Katherine and where the cats stare). Bill set up his video camera again facing from the door towards the shelf on the wall from where a neighbour had seen an object fly.

In addition Bill placed his emf meter on the mantelpiece over the fire and left it on for the whole investigation. Steph placed hers to eth right of the computer monitor.

During the investigation the owner's three cats, Angel (black), Pooky (white) and Tigger (ginger) were present.

The small, top light, of the window was open during a large part of the investigation but later closed as Catherine was being irritated by the sounds of children outside. As a result there were some sounds coming into the room including passing cars, trains and planes taking off from London Luton airport.

Vigil 1: 19:20 to 20:00

19:15 Steph measures the temperature as +24°C.

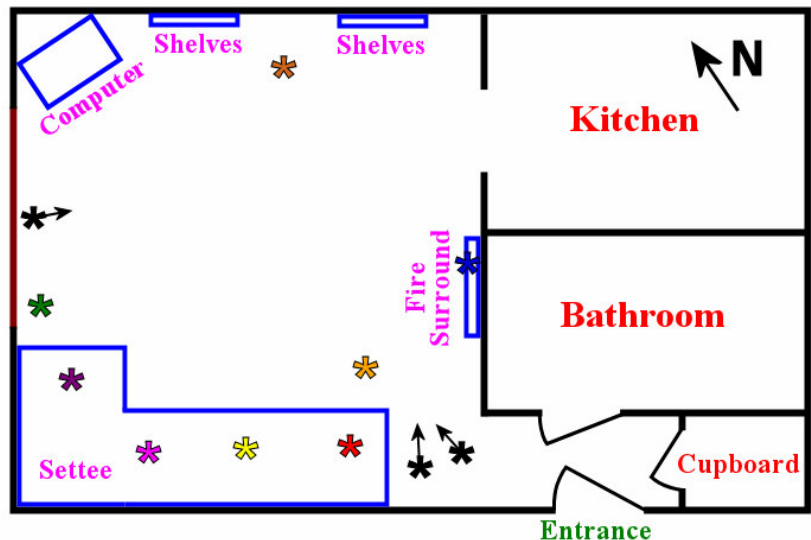
19:21 Bill measures the temperature at +19.5°C.

19:30 Steph notes the white cat (Pookie) appears to be either staring at Andy or the window behind him. She cannot tell which from her position.

19:40 The bathroom door opens and Marion and Elaine look at each other and pick the name Eric up.

19:44 Steph smells roses. This may be coming from the bathroom as it sounded like the cat has been scratching at the bathroom door and may have opened it.

19:49 A lot of banging is heard coming from somewhere above and beyond the front door (to the east). It included a strange sound like something being dropped.

19:50 Steph feels very cold to her right. Temperature still reads 24°C.

19:56 Steph feels something touch the back of her head. She turns around to discover it is the black cat, Angel.

Between Vigils

20:02 After the vigil Steph inspects the bathroom and concludes that the rose smell did come from the bathroom and Bill confirmed that Pookie did open the bathroom door.

20:29 Andy placed his emf meter on the floor with his video camera recording it. Then Andy, Marion and Steph took it in turn to ask if there were any spirits present and to try to move the lights on the meter but there were no responses.

Steph stopped doing a video recording from the doorway so Andy moved his camera to where hers had been and recorded the corner of the room.

Vigil 2: 20:44 to 21:30

20:46 Steph picks up a woman waiving goodbye to a man who is on a large ship. There are lots of people there waiving goodbye.

20:56 A lot of noise is heard coming from the hall to the east including the loud sound of high-heeled shoes.

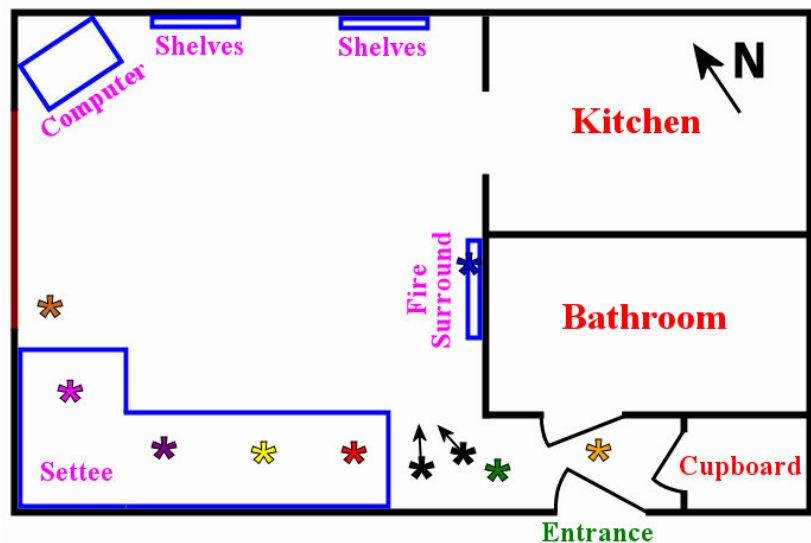
20:57 Steph gets a strong urge to laugh but has no idea why.

21:11 Steph has a dull pain on the top of her head which is only on one point on the left side of her head.

21:15 Steph sees two small blue flashes of light to the right of Catherine's head.

Bill tries an experiment by allowing his mind to drift off and see if anything pops into it. This was unplanned and came about because he had had a couple of odd things come to his mind during the quiet vigil but had not noted them down so he decided to try it properly and record the results. The first time he tried it he got *lots of herbs* and the second time *tomali*.

During the investigation Marion picked up the name *Geoffrey/Jeffrey Marshall* and *fishmonger*.
