<p><b>Background</b></p> <p>The Investigation site of the Grand Union Canal has no recorded paranormal history. However as this was our fourth investigation in a decade, we would be to differ given those recorded results. Historically it is said that the body of a witch passed over the canal bridge carried on a wagon by local people after being drowned in a nearby pond (another location LPS has investigated in the past) on the way to be laid out at a nearby public house awaiting collection.</p> <p>On previous investigations especially in 2017. Members investigating found one female spirit under the bridge who wanted to communicate and more along the canal itself, (see our you tube site for film of that investigation).</p> <p>Team members consisting of Andy, Ben, Maria and Richard K made their way to Gubblecote Canal which is situated a short distance from the small village of Pitstone, Bucks.</p> <p><b>Equipment</b></p> <p>Andy: SP7, Pen and pad, Torch, EMF meter, Sound recorder, Night vision camcorder  Ben: Cat Balls, Pen and Pad, Torch.  Richard: Pen and pad.  Marie: Pen and pad</p> <p><b>Pre-Investigation;</b></p> <p><b>Weather:</b> Light cloud and dry.</p> <p><b>Ambient Sounds:</b> Traffic beeping as they went over the bridge. Aircraft flying over head as the location is under the flight path for Luton Airport. Furth to this the sound of water coming through the lock gates was worse than on previous occasions.</p> <p><b>Other contaminates:</b> Barges and people nearby and only one family passed us by on the footpath.</p> <p><b>Investigation begins:</b></p> <p>20:45 - Arrival at location. Sun is still very much out but it is a beautiful summers evening.</p> <p>21:00 - All team members make their way up to an area of the Canal that they would refer to on the evening as Lock Two situated about two hundred metres up the canal tow path from the vehicle parking laybys.</p> <p>Four motion detector balls are placed by Ben in various locations near to the canal edge. A family taking a evening stroll walk past the team but do not stop to speak.</p> <p>A silent vigil is commenced to tune into the surroundings. Ben announces that he senses World war 2 Soldiers walking up the tow path towards the team walking in side by side formation. Ben estimates that there are several hundred men but there are no motion detector ball activation's and the vigil is concluded at 21:25</p> <p>21:33 - SP7 experiment conducted at Lock one which is situated near to the bridge. Three motion detector balls are placed in various areas but there are no activation's.</p>		

Ben struggles to hear the SP7 without headphones and the only word he picks up on is the word 'We' together with a clicking noise which appears to emanate from the direction of the Lock gate which is timed at 21:45

22:00 - End of experiment and as it is still light the team return to the cars for a quick break. Ben notes that Richard is extremely quiet and appears a little distant from the other team members present.

22:30 - PSB7 experiment conducted under the bridge but the sound of flowing water from the nearby lock walls makes it difficult to hear and at 22:40 the team take the decision to move back to the area around Lock one. It is dark by now and the night sky is clear with the only the occasional aircraft being seen overhead.

22:57 - Continuous motion detector ball activation which has been placed onto one of the mooring posts at the canal side. These activation go on continuously for about ten minutes.

23:04 - Ben and Richard both hear what sound like Horses hooves coming from behind them. There are no horses present and they cannot identify the source of the sounds.

23:15 Conclusion of the investigation.

### **Analysis**

Andy did not sense anything paranormal. Location always a good visit maybe to be linked to the site where the village pond use to be and the witch was drowned in future.

Nothing paranormal on audio or film.

Ben did not pick up on much at this location and felt that the area overall was quite peaceful and tranquil.
